- PROVIDES CUSTOMERS WITH INFORMATION ABOUT INVESTMENTS, MAKES SUITABLE RECOMMENDATIONS, TRANSFERS ASSETS AND MAINTAINS CUSTOMER ACCOUNTS
- OBTAINS AND VERIFIES CUSTOMERS' PURCHASE AND SALES INSTRUCTIONS AND AGREEMENTS; PROCESSES, COMPLETES AND CONFIRMS TRANSACTIONS

RETIREMENT PLANS AND INSURANCE PRODUCTS

5. **BREAK-EVEN POINT FOR OPTIONS:** THE STRIKE PRICE PLUS THE PREMIUM PAID (CALL OPTION) OR STRIKE PRICE MINUS THE PREMIUM PAID (PUT OPTION).

REGULATORY AND COMPLIANCE ESSENTIALS
