3. ANTI-DISCRIMINATION LAWS: IN MANY PLACES, LEGAL PROTECTIONS EXIST TO PREVENT DISCRIMINATION BASED ON SEXUAL ORIENTATION AND GENDER IDENTITY, ALTHOUGH ENFORCEMENT CAN VARY.

CHANGING ATTITUDES AND LEGAL REFORMS

AS SOCIETY'S UNDERSTANDING OF SEXUAL ORIENTATION AND GENDER IDENTITY EVOLVES, SO TOO DO THE LAWS THAT GOVERN

THESE ISSUES.

DECRIMINALIZATION OF HOMOSEXUALITY

MANY COUNTRIES HAVE MOVED TO DECRIMINALIZE HOMOSEXUAL ACTS AND RECOGNIZE SAME-SEX MARRIAGES. FOR INSTANCE, IN THE PAST TWO DECADES, NUMEROUS NATIONS HAVE LEGALIZED SAME-SEX MARRIAGE, REFLECTING A SIGNIFICANT SHIFT IN PUBLIC OPINION.

RECOGNIZING GENDER IDENTITY

THE FUTURE OF SEXUAL TABOOS AND LAW
