

SOCIAL SCIENCE AND PUBLIC POLICY

UNDERSTANDING SOCIAL SCIENCE

5. ANTHROPOLOGY: EXPLORES CULTURAL VARIATIONS AMONG HUMANS. ANTHROPOLOGISTS STUDY HOW CULTURE INFLUENCES BEHAVIOR AND SOCIAL STRUCTURES.

THE IMPORTANCE OF SOCIAL SCIENCE

THE ROLE OF PUBLIC POLICY

PUBLIC POLICY REFERS TO THE PRINCIPLES AND REGULATIONS ESTABLISHED BY AUTHORITIES TO ADDRESS SOCIETAL NEEDS AND CHALLENGES. IT INVOLVES A SYSTEMATIC PROCESS STARTING FROM PROBLEM IDENTIFICATION TO THE EVALUATION OF
