KEY LEGISLATION IMPACTING SPECIAL EDUCATION

1. INDIVIDUALS WITH DISABILITIES EDUCATION ACT (IDEA): THIS LANDMARK LAW ENSURES THAT CHILDREN WITH DISABILITIES HAVE THE RIGHT TO FREE AND APPROPRIATE PUBLIC EDUCATION (FAPE) TAILORED TO THEIR INDIVIDUAL NEEDS.

- **PARENT TRAINING AND INFORMATION CENTERS (PTIs):** PROVIDE INFORMATION AND RESOURCES TO PARENTS OF CHILDREN WITH DISABILITIES, HELPING THEM UNDERSTAND THEIR RIGHTS AND NAVIGATE THE EDUCATIONAL SYSTEM.
