2. ISBAR (INTRODUCTION, SITUATION, BACKGROUND, ASSESSMENT,

RECOMMENDATION)

ISBAR IS AN EXTENSION OF SBAR, INCORPORATING AN INTRODUCTION TO CLARIFY WHO IS SPEAKING AND THEIR ROLE.

- INTRODUCTION: INTRODUCE YOURSELF AND YOUR ROLE.
- SITUATION: DESCRIBE THE CURRENT SITUATION.
- BACKGROUND: OFFER ANY RELEVANT PATIENT HISTORY OR CONTEXT.
- ASSESSMENT: SHARE YOUR CLINICAL ASSESSMENT.
- RECOMMENDATION: PROPOSE WHAT SHOULD BE DONE NEXT.

3. CHECKLISTS

CHECKLISTS ARE WIDELY USED IN VARIOUS HEALTHCARE SETTINGS TO ENSURE THAT CRITICAL STEPS ARE NOT OVERLOOKED. THEY ARE ESPECIALLY PREVALENT IN SURGICAL ENVIRONMENTS BUT CAN BE ADAPTED FOR VARIOUS CLINICAL SCENARIOS.

- PRE-OPERATIVE CHECKLISTS: ENSURE ALL NECESSARY PREPARATIONS ARE COMPLETED BEFORE SURGERY.

- SITUATION AWARENESS: HIGHLIGHT ANY CRITICAL CONCERNS.
- SYNTHESIS: CONFIRM UNDERSTANDING OF THE INFORMATION.

5. ELECTRONIC HEALTH RECORDS (EHRs)

EHRs ARE DIGITAL VERSIONS OF PATIENTS' PAPER CHARTS AND ARE CRITICAL IN STANDARDIZED COMMUNICATION. THEY ALLOW HEALTHCARE PROVIDERS TO:
