### TAX OBLIGATIONS AND EMPLOYER REQUIREMENTS

## CHOOSING THE RIGHT BUSINESS STRUCTURE

### SOLE PROPRIETORSHIP AND PARTNERSHIPS

A SOLE PROPRIETORSHIP IS THE SIMPLEST AND MOST COMMON FORM OF BUSINESS, OFFERING FULL CONTROL TO THE OWNER BUT WITH UNLIMITED PERSONAL LIABILITY. PARTNERSHIPS INVOLVE TWO OR MORE INDIVIDUALS SHARING OWNERSHIP, PROFITS, AND LIABILITIES. THESE STRUCTURES ARE EASY TO ESTABLISH BUT MAY POSE RISKS REGARDING PERSONAL ASSET PROTECTION. IN UTAH, REGISTERING A "DOING BUSINESS AS" (DBA) NAME IS OFTEN REQUIRED FOR SOLE PROPRIETORSHIPS AND PARTNERSHIPS OPERATING UNDER A TRADE NAME.

### LIMITED LIABILITY COMPANIES (LLCS) AND CORPORATIONS

LLCS PROVIDE LIABILITY PROTECTION FOR OWNERS WHILE ALLOWING FLEXIBLE MANAGEMENT AND PASS-THROUGH TAXATION. THIS STRUCTURE IS POPULAR AMONG UTAH SMALL BUSINESS OWNERS FOR BALANCING SIMPLICITY AND LEGAL SAFEGUARDS. CORPORATIONS, INCLUDING S CORPORATIONS AND C CORPORATIONS, OFFER STRONG LIABILITY PROTECTION AND POTENTIAL TAX BENEFITS BUT INVOLVE MORE COMPLEX COMPLIANCE AND FORMALITIES. CHOOSING THE CORRECT STRUCTURE DEPENDS ON FACTORS SUCH AS THE DESIRED LEVEL OF LIABILITY PROTECTION, TAX CONSIDERATIONS, AND BUSINESS GOALS.

# REGISTERING YOUR BUSINESS AND LICENSES

PROPER REGISTRATION IS ESSENTIAL TO LEGALLY OPERATE A BUSINESS IN UTAH. THIS PROCESS INCLUDES FILING FORMATION DOCUMENTS, OBTAINING AN EMPLOYER IDENTIFICATION NUMBER (EIN), AND SECURING NECESSARY PERMITS AND LICENSES. EACH STEP ENSURES THE BUSINESS MEETS LOCAL, STATE, AND FEDERAL REQUIREMENTS.

## FILING FORMATION DOCUMENTS

FOR LLCs AND CORPORATIONS, FILING ARTICLES OF ORGANIZATION OR INCORPORATION WITH THE UTAH DIVISION OF CORPORATIONS IS REQUIRED. THIS STEP OFFICIALLY CREATES THE BUSINESS ENTITY AND INCLUDES DETAILS SUCH AS THE BUSINESS NAME, REGISTERED AGENT, AND MANAGEMENT STRUCTURE. SOLE PROPRIETORSHIPS AND PARTNERSHIPS TYPICALLY REGISTER A DBA IF OPERATING UNDER A NAME DIFFERENT FROM THE OWNERS' LEGAL NAMES.

## OBTAINING PERMITS AND LICENSES

DEPENDING ON THE NATURE OF THE BUSINESS, VARIOUS PERMITS AND LICENSES MAY BE REQUIRED. COMMON TYPES INCLUDE:

- GENERAL BUSINESS LICENSE FROM THE CITY OR COUNTY
- HEALTH DEPARTMENT PERMITS FOR FOOD-RELATED BUSINESSES
- PROFESSIONAL LICENSES FOR REGULATED OCCUPATIONS
- SALES TAX LICENSE FOR RETAIL BUSINESSES

ENSURING ALL PERMITS ARE OBTAINED BEFORE OPENING PREVENTS LEGAL INTERRUPTIONS AND FINES.

# FINANCING YOUR SMALL BUSINESS

- ECONOMIC DEVELOPMENT LOAN FUND

- LOCAL CHAMBER OF COMMERCE FUNDING INITIATIVES

THESE PROGRAMS OFTEN HAVE ELIGIBILITY CRITERIA BASED ON BUSINESS SIZE, LOCATION, AND INDUSTRY SECTOR.

### WHAT TYPES OF BUSINESS STRUCTURES ARE AVAILABLE FOR SMALL BUSINESSES IN UTAH?
