ELIGIBILITY REQUIREMENTS FOR THE STATE BOARD EXAM

BEFORE REGISTERING FOR THE STATE BOARD EXAM COSMETOLOGY CALIFORNIA, CANDIDATES MUST MEET SPECIFIC ELIGIBILITY CRITERIA SET BY THE CALIFORNIA BOARD OF BARBERING AND COSMETOLOGY. THESE REQUIREMENTS ENSURE THAT APPLICANTS HAVE RECEIVED ADEQUATE EDUCATION AND TRAINING TO COMPLY WITH PROFESSIONAL STANDARDS.

EDUCATIONAL PREREQUISITES
