TAKING THE NOTARY TEST

AFTER THE NOTARY TEST

ONCE YOU HAVE COMPLETED THE EXAM, YOU WILL TYPICALLY RECEIVE YOUR RESULTS WITHIN A FEW WEEKS. IF YOU PASS, YOU WILL THEN NEED TO COMPLETE ADDITIONAL STEPS TO BECOME A COMMISSIONED NOTARY PUBLIC, INCLUDING:

1. FILING YOUR OATH OF OFFICE WITH THE PARISH CLERK OF COURT.
2. OBTAINING A SURETY BOND.
3. PURCHASING NOTARY SUPPLIES, SUCH AS A SEAL AND JOURNAL.
