STEPS TO OBTAIN YOUR REAL ESTATE LICENSE

HERE ARE THE STEPS YOU NEED TO FOLLOW TO SECURE YOUR REAL ESTATE LICENSE:

1. COMPLETE REQUIRED COURSES: ENROLL IN AND COMPLETE THE REQUIRED REAL ESTATE COURSES.
2. APPLY FOR THE EXAM: FILL OUT THE APPLICATION FORM AND SUBMIT IT TO THE DRE ALONG WITH THE NECESSARY FEES.
3. SCHEDULE YOUR EXAM: ONCE YOUR APPLICATION IS APPROVED, YOU CAN SCHEDULE YOUR EXAM DATE THROUGH AN APPROVED TESTING CENTER.

READ QUESTIONS CAREFULLY

DURING THE EXAM, TAKE YOUR TIME TO READ EACH QUESTION THOROUGHLY. PAY ATTENTION TO KEYWORDS AND PHRASES TO ENSURE YOU UNDERSTAND WHAT IS BEING ASKED.

MANAGE YOUR TIME WISELY

BE MINDFUL OF THE TIME DURING THE EXAM. IF YOU ENCOUNTER A CHALLENGING QUESTION, IT MAY BE BEST TO SKIP IT AND COME BACK LATER IF TIME PERMITS.
