IF A NOTARY SUSPECTS THAT A SIGNER IS BEING COERCED, THEY SHOULD REFUSE TO PERFORM THE NOTARIZATION AND INFORM THE SIGNER OF THEIR RIGHTS.

WHAT ARE THE PENALTIES FOR NOTARIES WHO VIOLATE NEW YORK NOTARY LAWS?

PENALTIES FOR VIOLATING NEW YORK NOTARY LAWS CAN INCLUDE FINES, SUSPENSION OR REVOCATION OF NOTARY COMMISSION, AND POTENTIAL LEGAL ACTION.
