UNDERSTANDING FINANCING OPTIONS CAN HELP AGENTS ASSIST BUYERS EFFECTIVELY. KEY TOPICS INCLUDE:

- TYPES OF MORTGAGES (FIXED-RATE, ADJUSTABLE-RATE, FHA, VA)
- LOAN APPROVAL PROCESS
- CLOSING COSTS AND SETTLEMENT STATEMENTS

5. PROPERTY MANAGEMENT AND INVESTMENT

FOR AGENTS INVOLVED IN PROPERTY MANAGEMENT, UNDERSTANDING THESE CONCEPTS IS CRUCIAL:

- RESPONSIBILITIES OF A PROPERTY MANAGER
- TENANT RIGHTS AND LANDLORD OBLIGATIONS

5. FLASHCARDS FOR KEY TERMS

CREATING FLASHCARDS FOR IMPORTANT TERMS, LAWS, AND CONCEPTS CAN AID IN MEMORIZATION. REVIEW THESE FLASHCARDS REGULARLY TO REINFORCE YOUR UNDERSTANDING OF CRITICAL CONTENT.

EXAM DAY PREPARATION
