CANDIDATES MUST COMPLETE A MASSAGE THERAPY EDUCATION PROGRAM WITH A MINIMUM OF 500 HOURS FROM AN ACCREDITED SCHOOL AND SUBMIT AN APPLICATION TO THE TEXAS DEPARTMENT OF LICENSING AND REGULATION (TDLR) BEFORE TAKING THE EXAM.

HOW CAN I PREPARE FOR THE TEXAS MASSAGE THERAPY LICENSING EXAM?

AFTER PASSING, SUBMIT YOUR APPLICATION FOR LICENSURE TO THE TEXAS DEPARTMENT OF LICENSING AND REGULATION (TDLR), COMPLETE ANY REQUIRED BACKGROUND CHECKS OR FINGERPRINTING, AND PAY THE LICENSING FEES TO RECEIVE YOUR MASSAGE THERAPY LICENSE.
