PEER REVIEW PROCEDURE

ONCE SUBMITTED, MANUSCRIPTS UNDERGO INITIAL EDITORIAL SCREENING FOLLOWED BY A DOUBLE-BLIND PEER REVIEW BY EXPERTS IN THE FIELD. REVIEWERS ASSESS THE SCIENTIFIC VALIDITY, METHODOLOGICAL RIGOR, AND SIGNIFICANCE OF THE FINDINGS. BASED ON REVIEWER FEEDBACK, MANUSCRIPTS MAY BE ACCEPTED, REVISED, OR REJECTED.
