ROOT CAUSES OF THE COMING WAR WITH CHINA

GEOPOLITICAL FLASHPOINTS AND STRATEGIC INTERESTS

SOUTH CHINA SEA DISPUTES

THROUGH THE "NINE-DASH LINE." THIS CONFLICTS WITH CLAIMS FROM COUNTRIES LIKE VIETNAM, THE PHILIPPINES, AND MALAYSIA, AND CHALLENGES INTERNATIONAL MARITIME LAW.

TAIWAN STRAIT TENSIONS

TAIWAN REMAINS A CRITICAL FLASHPOINT. CHINA VIEWS TAIWAN AS A BREAKAWAY PROVINCE AND HAS NOT RULED OUT THE USE OF FORCE TO ACHIEVE REUNIFICATION. THE UNITED STATES MAINTAINS A POLICY OF STRATEGIC AMBIGUITY BUT CONTINUES TO SUPPORT TAIWAN'S DEFENSE CAPABILITIES, INCREASING THE RISK OF CONFRONTATION.

INDIA-CHINA BORDER CONFLICT

ALONG THE HIMALAYAN BORDER, CHINA AND INDIA HAVE LONGSTANDING DISPUTES LEADING TO PERIODIC SKIRMISHES. THE INCREASING MILITARIZATION OF THE REGION ADDS ANOTHER LAYER OF COMPLEXITY TO THE COMING WAR WITH CHINA SCENARIO.

MILITARY CAPABILITIES AND MODERNIZATION

TECHNOLOGICAL ADVANCEMENTS

CHINA'S MILITARY DOCTRINE EMPHASIZES ASYMMETRIC WARFARE, ANTI-ACCESS/AREA DENIAL (A2/AD) STRATEGIES, AND RAPID MOBILIZATION. THESE DOCTRINES ARE DESIGNED TO DETER INTERVENTION AND PROTECT CHINA'S CORE INTERESTS IN ANY CONFLICT SCENARIO.

ECONOMIC IMPLICATIONS AND TRADE CONFLICTS

THE COMING WAR WITH CHINA EXTENDS BEYOND MILITARY CONFRONTATION TO SIGNIFICANT ECONOMIC DIMENSIONS. TRADE TENSIONS, SUPPLY CHAIN DEPENDENCIES, AND SANCTIONS PLAY CRITICAL ROLES IN SHAPING THE BROADER CONFLICT LANDSCAPE.

TRADE DISPUTES AND TARIFFS
