RELIGIOUS AND SOCIAL INFLUENCES

RELIGIOUS ZEAL AND GENUINE BELIEF

SOME ACCUSERS WERE MOTIVATED BY SINCERE BELIEF IN THE PRESENCE OF WITCHES AND A DESIRE TO PROTECT THEIR COMMUNITY FROM SATANIC HARM. THIS RELIGIOUS FERVOR WAS A POWERFUL FORCE IN SUSTAINING THE TRIALS.

JUDICIAL PROCEEDINGS AND THE ROLE OF THE COURT
