MAX WEBER'S RATIONALIZATION THESIS

MAX WEBER'S CONCEPT OF RATIONALIZATION FURTHER ELUCIDATES THE DIALECTICAL RELATIONSHIP. WEBER ARGUED THAT MODERN SOCIETY INCREASINGLY PRIORITIZES CALCULABILITY, EFFICIENCY, AND CONTROL, ATTRIBUTES ASSOCIATED WITH RATIONALIZATION.
