MIGRATION PATTERNS INTO EUROPE

SEVERAL WAVES OF MIGRATION SHAPED THE DEMOGRAPHIC LANDSCAPE OF PREHISTORIC EUROPE. EARLY HUNTER-GATHERERS WERE LATER JOINED BY NEOLITHIC FARMERS MIGRATING FROM THE NEAR EAST AROUND 9,000 YEARS AGO AND INDO-EUROPEAN PASTORALISTS FROM THE EURASIAN STEPPE APPROXIMATELY 5,000 YEARS AGO. THESE MOVEMENTS CONTRIBUTED TO THE GENETIC DIVERSITY AND CULTURAL COMPLEXITY THAT WOULD CHARACTERIZE EUROPEAN POPULATIONS.

ANCIENT CIVILIZATIONS AND CULTURAL FOUNDATIONS

AS PREHISTORIC POPULATIONS TRANSITIONED INTO SETTLED SOCIETIES, THE ANCIENT CIVILIZATIONS OF EUROPE LAID CULTURAL AND SOCIAL FOUNDATIONS THAT INFLUENCED THE IDENTITY OF WHITE PEOPLE. ANCIENT GREECE AND ROME, IN PARTICULAR, PLAYED PIVOTAL ROLES IN SHAPING WESTERN CIVILIZATION THROUGH ADVANCEMENTS IN PHILOSOPHY, GOVERNANCE, ART, AND SCIENCE.

ANCIENT GREECE

ANCIENT GREECE, FLOURISHING FROM AROUND THE 8TH CENTURY BCE, IS OFTEN REGARDED AS THE CRADLE OF WESTERN CULTURE. ROMAN EMPIRE

THE ROMAN EMPIRE EXPANDED ACROSS EUROPE, NORTH AFRICA, AND THE NEAR EAST, INTEGRATING DIVERSE PEOPLES UNDER A VAST POLITICAL AND CULTURAL SYSTEM. ROMANS CONTRIBUTED TO INFRASTRUCTURE, LAW, AND GOVERNANCE, SHAPING THE SUBSEQUENT DEVELOPMENT OF EUROPEAN SOCIETIES.
