- **SUBPOENA:** A DOCUMENT ORDERING A PERSON TO ATTEND COURT OR PRODUCE EVIDENCE.
- **LITIGATION:** THE PROCESS OF TAKING LEGAL ACTION.
- **VERDICT:** THE DECISION OF A JURY OR JUDGE ON A MATTER SUBMITTED TO THEM FOR DELIBERATION.

UNDERSTANDING THESE TERMS CAN HELP YOU NOT ONLY SOLVE CROSSWORD CLUES BUT ALSO APPRECIATE THE CONTEXT IN WHICH THEY ARE USED.

TYPES OF CLUES RELATED TO LAW

3. RESEARCH AND REFERENCE

DON'T HESITATE TO REFERENCE LEGAL DICTIONARIES OR ONLINE RESOURCES WHEN YOU ENCOUNTER UNFAMILIAR TERMS.

WEBSITES LIKE CORNELL LAW SCHOOL'S LEGAL INFORMATION INSTITUTE CAN BE BENEFICIAL FOR QUICKLY CHECKING DEFINITIONS.

4. PRACTICE WITH THEMED PUZZLES

MANY NEWSPAPERS AND ONLINE PLATFORMS OFFER THEMED CROSSWORD PUZZLES FOCUSING ON LAW AND GOVERNMENT. PRACTICING WITH THESE CAN ENHANCE YOUR SKILLS AND FAMILIARITY WITH LEGAL TERMINOLOGY.
