PREDECESSORS TO THE MODERN HIGH SCHOOL

BEFORE THE ESTABLISHMENT OF PUBLIC HIGH SCHOOLS, SEVERAL FORMS OF SECONDARY EDUCATION EXISTED, INCLUDING:

- PRIVATE ACADEMIES THAT EMPHASIZED CLASSICAL LANGUAGES AND LITERATURE
- LATIN GRAMMAR SCHOOLS PREPARING STUDENTS FOR HIGHER EDUCATION
- APPRENTICESHIP AND VOCATIONAL TRAINING OUTSIDE FORMAL SCHOOLING
- DAME SCHOOLS AND OTHER INFORMAL EDUCATIONAL SETTINGS

THESE EARLY INSTITUTIONS LAID THE GROUNDWORK FOR A MORE SYSTEMATIC APPROACH TO SECONDARY EDUCATION, WHICH WOULD EMERGE IN THE 19TH CENTURY.

INITIALLY, HIGH SCHOOLS PRIMARILY SERVED MIDDLE-CLASS BOYS, BUT OVER TIME, EDUCATIONAL OPPORTUNITIES EXPANDED FOR GIRLS AND WORKING-CLASS YOUTH, REFLECTING BROADER SOCIAL CHANGES AND DEMANDS FOR EQUALITY.

EDUCATIONAL REFORMS AND CURRICULUM CHANGES
