SEXUAL REGULATION IN ANCIENT AND MEDIEVAL SOCIETIES

ANCIENT CIVILIZATIONS SUCH AS GREECE AND ROME HAD COMPLEX ATTITUDES TOWARD SEXUALITY, OFTEN TOLERATING OR EVEN CELEBRATING CERTAIN NON-HETERONORMATIVE BEHAVIORS UNDER SPECIFIC SOCIAL CONTEXTS. HOWEVER, WITH THE RISE OF ORGANIZED RELIGIONS LIKE CHRISTIANITY AND ISLAM, MANY SEXUAL PRACTICES CAME UNDER STRICTER MORAL SCRUTINY. MEDIEVAL LAWS AND CHURCH DOCTRINES IMPOSED SIGNIFICANT RESTRICTIONS ON SEXUAL EXPRESSION, PARTICULARLY CONCERNING PREMARITAL SEX, HOMOSEXUALITY, AND REPRODUCTIVE RIGHTS.

THE SEXUAL REVOLUTION AND POLITICAL SHIFTS

THE 20TH CENTURY WITNESSED SIGNIFICANT POLITICAL SHIFTS REGARDING HUMAN SEXUALITY, ESPECIALLY DURING THE SEXUAL REVOLUTION OF THE 1960S AND 1970S. THIS PERIOD CHALLENGED TRADITIONAL NORMS, ADVOCATING FOR SEXUAL LIBERATION, GENDER EQUALITY, AND LGBTQ+ RIGHTS. MARRIAGE EQUALITY AND LGBTQ+ RIGHTS

REPRODUCTIVE RIGHTS AND ACCESS TO HEALTHCARE

EDUCATION AND SEXUALITY POLITICS

SEXUALITY EDUCATION IS A CONTENTIOUS POLITICAL ISSUE IN MANY REGIONS. DEBATES CENTER ON WHETHER EDUCATION SHOULD BE ABSTINENCE-BASED OR COMPREHENSIVE, THE INCLUSION OF LGBTQ+ TOPICS, AND PARENTAL RIGHTS IN DETERMINING CURRICULUM.
