METHODOLOGIES IN CRIMINOLOGY AND CRIMINAL JUSTICE RESEARCH

QUALITATIVE RESEARCH

- ETHNOGRAPHY: THIS IMMERSIVE APPROACH INVOLVES RESEARCHERS ENGAGING WITH COMMUNITIES OR SPECIFIC POPULATIONS TO OBSERVE BEHAVIORS AND INTERACTIONS IN REAL-TIME.

CHALLENGES IN CRIMINOLOGY AND CRIMINAL JUSTICE RESEARCH

3. INTERDISCIPLINARY APPROACHES: CRIMINOLOGY AND CRIMINAL JUSTICE RESEARCH WILL BENEFIT FROM INTERDISCIPLINARY COLLABORATIONS, DRAWING ON INSIGHTS FROM SOCIOLOGY, PSYCHOLOGY, PUBLIC HEALTH, AND ECONOMICS. THIS HOLISTIC

APPROACH CAN LEAD TO A DEEPER UNDERSTANDING OF CRIME AND BETTER-INFORMED POLICY SOLUTIONS.
