SOCIAL INJUSTICE AND CLASS DISPARITIES

STEFFENS'S INVESTIGATIONS ALSO SHED LIGHT ON THE STARK CLASS DIVIDES PRESENT IN AMERICAN CITIES. HE ILLUSTRATED HOW:

- THE WEALTHY ELITE OFTEN EXPLOITED THE WORKING CLASS, PERPETUATING CYCLES OF POVERTY.

THE IMPACT OF THE SHAME OF THE CITIES

INFLUENCE ON THE PROGRESSIVE MOVEMENT

- FOUNDATION FOR MODERN JOURNALISM: STEFFENS'S COMMITMENT TO FACT-BASED REPORTING AND SOCIAL JUSTICE LAID THE GROUNDWORK FOR CONTEMPORARY JOURNALISM PRACTICES, EMPHASIZING THE JOURNALIST'S ROLE AS A WATCHDOG OF DEMOCRACY.
- CONTINUED RELEVANCE: THE THEMES EXPLORED IN THE SHAME OF THE CITIES RESONATE TODAY, AS CITIES AROUND THE WORLD GRAPPLE WITH ISSUES OF CORRUPTION, INEQUALITY, AND SOCIAL JUSTICE.
