THE *SUMMA PERFECTIONIS* EMERGED IN THE LATIN WEST DURING THE LATE 13TH OR EARLY 14TH CENTURY, REFLECTING A SYNTHESIS OF ARABIC ALCHEMICAL KNOWLEDGE AND EUROPEAN INTELLECTUAL TRADITIONS.
