BENEFITS OF THERAPY DOGS

1. **REDUCED ANXIETY AND STRESS:** INTERACTING WITH THERAPY DOGS CAN LOWER CORTISOL LEVELS, LEADING TO A SENSE OF CALM.

4. **PROMOTION OF PHYSICAL ACTIVITY:** ENGAGING WITH THERAPY DOGS CAN ENCOURAGE MORE PHYSICAL MOVEMENT, CONTRIBUTING TO OVERALL HEALTH.
5. **SUPPORT IN HEALING:** IN MEDICAL SETTINGS, THERAPY DOGS CAN HELP PATIENTS COPE WITH PAIN AND IMPROVE OUTCOMES THROUGH EMOTIONAL SUPPORT.

THE CERTIFICATION PROCESS

IF YOU'RE CONSIDERING USING A THERAPY DOG IN MISSOURI, IT'S ESSENTIAL TO UNDERSTAND THE CERTIFICATION PROCESS. THIS ENSURES THAT THE DOG IS WELL-TRAINED AND CAPABLE OF PROVIDING THE NECESSARY SUPPORT. BELOW, WE OUTLINE THE STEPS INVOLVED IN THERAPY DOG CERTIFICATION:

STEP 1: CHOOSE THE RIGHT DOG

NOT ALL DOGS ARE SUITED FOR THERAPY WORK. KEY TRAITS TO LOOK FOR INCLUDE:

- **TEMPERAMENT:** THE DOG SHOULD BE FRIENDLY, CALM, AND ABLE TO INTERACT WELL WITH A VARIETY OF PEOPLE.

- **HEALTH:** THE DOG MUST BE IN GOOD HEALTH, UP-TO-DATE ON VACCINATIONS, AND HAVE A CLEAN BILL OF HEALTH FROM A VETERINARIAN.

STEP 2: BASIC TRAINING

BEFORE PURSUING CERTIFICATION, DOGS SHOULD UNDERGO BASIC OBEDIENCE TRAINING. ESSENTIAL COMMANDS INCLUDE:

- SIT
- STAY
- COME
- DOWN
- LEAVE IT

DOGS SHOULD ALSO BE COMFORTABLE WITH VARIOUS ENVIRONMENTS AND DISTRACTIONS, AS THERAPY WORK OFTEN TAKES PLACE IN BUSY SETTINGS.

STEP 3: SPECIALIZED THERAPY DOG TRAINING

AFTER MASTERING BASIC COMMANDS, DOGS CAN BENEFIT FROM SPECIALIZED THERAPY DOG TRAINING. THIS TRAINING FOCUSES ON:

- SOCIALIZATION: EXPOSING THE DOG TO DIFFERENT ENVIRONMENTS, PEOPLE, AND OTHER ANIMALS.
- DESENSITIZATION: HELPING THE DOG BECOME ACCUSTOMED TO VARIOUS STIMULI, SUCH AS LOUD NOISES OR SUDDEN MOVEMENTS.
- HANDLING SKILLS: TEACHING THE DOG TO REMAIN CALM WHEN BEING TOUCHED OR APPROACHED BY INDIVIDUALS.

STEP 4: CERTIFICATION TESTING

ONCE THE DOG HAS COMPLETED TRAINING, THE NEXT STEP IS TO UNDERGO A CERTIFICATION TEST. THIS EVALUATION TYPICALLY INCLUDES:

- BEHAVIOR ASSESSMENT: OBSERVING THE DOG'S REACTIONS TO VARIOUS SITUATIONS AND STIMULI.
- COMMAND EXECUTION: ENSURING THE DOG CAN FOLLOW BASIC COMMANDS IN A DISTRACTING ENVIRONMENT.
- INTERACTION EVALUATION: ASSESSING HOW THE DOG INTERACTS WITH PEOPLE, INCLUDING THOSE WITH DISABILITIES OR MEDICAL CONDITIONS.

SEVERAL ORGANIZATIONS OFFER CERTIFICATION FOR THERAPY DOGS IN MISSOURI, INCLUDING:

- THERAPY DOGS INTERNATIONAL (TDI)
- ALLIANCE OF THERAPY DOGS (ATD)
- PET PARTNERS

EACH ORGANIZATION HAS ITS OWN SPECIFIC REQUIREMENTS AND TESTING PROCEDURES, SO IT'S ESSENTIAL TO RESEARCH WHICH ONE ALIGNS BEST WITH YOUR GOALS.

LEGAL CONSIDERATIONS IN MISSOURI

WHILE THERAPY DOGS PROVIDE INVALUABLE SUPPORT, IT'S IMPORTANT TO UNDERSTAND THE LEGAL CONTEXT SURROUNDING THEIR USE. THERAPY DOGS ARE NOT CONSIDERED SERVICE ANIMALS UNDER THE AMERICANS WITH DISABILITIES ACT (ADA), WHICH MEANS THEY DO NOT HAVE THE SAME ACCESS RIGHTS.

PUBLIC ACCESS RIGHTS

THERAPY DOGS TYPICALLY DO NOT HAVE THE LEGAL RIGHT TO ACCOMPANY THEIR HANDLERS IN ALL PUBLIC SPACES. HOWEVER,

MANY FACILITIES, SUCH AS HOSPITALS AND SCHOOLS, WELCOME THERAPY DOGS AND MAY HAVE THEIR OWN POLICIES IN PLACE REGARDING THEIR PRESENCE.

INSURANCE AND LIABILITY

HANDLERS SHOULD ALSO CONSIDER LIABILITY INSURANCE, WHICH CAN PROVIDE PROTECTION IN CASE OF ACCIDENTS OR INCIDENTS INVOLVING THEIR THERAPY DOG. SOME CERTIFICATION ORGANIZATIONS MAY OFFER INSURANCE AS PART OF THEIR MEMBERSHIP, SO IT'S WORTH INVESTIGATING THESE OPTIONS.

GETTING INVOLVED WITH THERAPY DOGS

IF YOU'RE INTERESTED IN GETTING INVOLVED WITH THERAPY DOGS, EITHER AS A HANDLER OR THROUGH A PROGRAM, THERE ARE NUMEROUS WAYS TO DO SO IN MISSOURI.

VOLUNTEERING WITH ORGANIZATIONS

MANY ORGANIZATIONS IN MISSOURI PROVIDE OPPORTUNITIES TO VOLUNTEER WITH THERAPY DOGS. THIS CAN INCLUDE:

- VISITING HOSPITALS OR NURSING HOMES: BRINGING THERAPY DOGS TO FACILITIES TO INTERACT WITH PATIENTS.
- PARTICIPATING IN SCHOOL PROGRAMS: ASSISTING IN EDUCATIONAL SETTINGS WHERE DOGS CAN HELP CHILDREN READ OR PROVIDE EMOTIONAL SUPPORT.
- COMMUNITY EVENTS: JOINING LOCAL FAIRS OR FESTIVALS TO PROMOTE AWARENESS OF THE BENEFITS OF THERAPY DOGS.

FORMING A THERAPY DOG TEAM

INDIVIDUALS INTERESTED IN FORMING THEIR OWN THERAPY DOG TEAM CAN DO SO BY COMPLETING THE NECESSARY TRAINING AND CERTIFICATION. THIS CAN INVOLVE:

1. FINDING A TRAINING PROGRAM OR CERTIFIED TRAINER.
2. COMPLETING REQUIRED COURSEWORK AND PRACTICE SESSIONS.
3. APPLYING FOR CERTIFICATION WITH A RECOGNIZED ORGANIZATION.

FREQUENTLY ASKED QUESTIONS

WHAT IS THE PROCESS FOR CERTIFYING A THERAPY DOG IN MISSOURI?

HOW OLD DOES A DOG NEED TO BE TO START THERAPY DOG TRAINING IN MISSOURI?

THERAPY DOGS SHOULD UNDERGO BASIC OBEDIENCE TRAINING, SOCIALIZATION WITH DIFFERENT ENVIRONMENTS AND PEOPLE, AND SPECIFIC TRAINING THAT PREPARES THEM FOR THE TYPES OF INTERACTIONS THEY WILL HAVE IN THERAPY SETTINGS.

CAN THERAPY DOGS VISIT HOSPITALS AND SCHOOLS IN MISSOURI WITHOUT CERTIFICATION?

GENERALLY, THERAPY DOGS MUST BE CERTIFIED TO VISIT HOSPITALS, SCHOOLS, AND OTHER PUBLIC FACILITIES, AS CERTIFICATION ENSURES THAT THE DOG HAS MET SPECIFIC BEHAVIOR AND TEMPERAMENT STANDARDS.

WHAT ARE THE BENEFITS OF HAVING A THERAPY DOG CERTIFIED IN MISSOURI?

CERTIFIED THERAPY DOGS CAN PROVIDE COMFORT AND EMOTIONAL SUPPORT, HELP REDUCE ANXIETY AND STRESS, AND IMPROVE THE OVERALL WELL-BEING OF INDIVIDUALS IN THERAPEUTIC SETTINGS.
