RISK ASSESSMENT AND MANAGEMENT

LEGAL PSYCHOLOGY AND COURTROOM APPLICATIONS

OBTAINING INFORMED CONSENT IN FORENSIC EVALUATIONS IS COMPLEX SINCE INDIVIDUALS MAY FEEL COERCED OR UNSURE OF THEIR RIGHTS. PSYCHOLOGISTS MUST ENSURE THAT CONSENT IS VOLUNTARY AND THAT PARTICIPANTS UNDERSTAND THE PURPOSE AND LIMITS OF THE EVALUATION.

SPECIALIZED AREAS WITHIN FORENSIC PSYCHOLOGY
