AFFIRMATIVE AND NEGATIVE TEAMS

DEBATE PARTICIPANTS ARE TYPICALLY DIVIDED INTO TWO TEAMS: THE AFFIRMATIVE TEAM SUPPORTS THE RESOLUTION, WHILE THE NEGATIVE TEAM OPPOSES IT. EACH TEAM PRESENTS ARGUMENTS TO JUSTIFY THEIR STANCE AND REFUTE THE OPPOSING SIDE'S POINTS. UNDERSTANDING THE ROLES AND RESPONSIBILITIES OF EACH TEAM IS FUNDAMENTAL TO A BALANCED AND EFFECTIVE DEBATE.

CONSTRUCTIVE SPEECHES

REBUTTAL AND CROSS-EXAMINATION

PUBLIC FORUM DEBATE

PUBLIC FORUM DEBATE IS DESIGNED TO BE ACCESSIBLE AND AUDIENCE-FRIENDLY. TEAMS OF TWO ARGUE FOR OR AGAINST A RESOLUTION WITH A FOCUS ON CLEAR COMMUNICATION AND PERSUASIVE TACTICS. IT BALANCES EVIDENCE-BASED ARGUMENTS WITH RHETORICAL SKILL.

PARLIAMENTARY DEBATE
