2. INTERACTIVE LEARNING METHODS

3. SELF-MOTIVATION REQUIRED

ONLINE LEARNING REQUIRES A HIGHER DEGREE OF SELF-MOTIVATION AND DISCIPLINE. PARTICIPANTS MUST BE PROACTIVE IN MANAGING THEIR TIME AND COMPLETING ASSIGNMENTS WITHOUT THE STRUCTURE OF A TRADITIONAL CLASSROOM.
