- FULL NAME
- DATE OF BIRTH
- COUNTRY OF ORIGIN
- CURRENT ADDRESS
- THE RELATIONSHIP TO YOU (THE SPONSOR)

STEP 4: FINANCIAL INFORMATION

THIS SECTION IS CRITICAL, AS IT DEMONSTRATES YOUR ABILITY TO PROVIDE FINANCIAL SUPPORT. YOU WILL NEED TO INCLUDE:

- YOUR ANNUAL INCOME
- YOUR EMPLOYMENT STATUS
- DETAILS ABOUT YOUR CURRENT FINANCIAL OBLIGATIONS (E.G., RENT/MORTGAGE, LOANS)
- SUPPORTING DOCUMENTATION, SUCH AS TAX RETURNS, PAY STUBS, OR BANK STATEMENTS

STEP 5: DECLARATION AND SIGNATURE

- PROOF OF YOUR U.S. CITIZENSHIP OR LAWFUL PERMANENT RESIDENCY (SUCH AS A PASSPORT OR GREEN CARD).
- RECENT TAX RETURNS (USUALLY THE LAST THREE YEARS).
- PAY STUBS OR EMPLOYMENT VERIFICATION LETTERS.
- BANK STATEMENTS TO SHOW AVAILABLE FUNDS.
- ANY ADDITIONAL DOCUMENTATION THAT SUPPORTS YOUR FINANCIAL CAPABILITY.

How TO SUBMIT FORM I-134A

ONCE YOU HAVE COMPLETED FORM I-134A AND GATHERED ALL NECESSARY DOCUMENTATION, YOU CAN SUBMIT IT THROUGH THE USCIS ONLINE FILING SYSTEM. HERE'S HOW:

1. LOG IN TO THE USCIS ONLINE ACCOUNT.
2. FOLLOW THE PROMPTS TO UPLOAD YOUR COMPLETED FORM AND SUPPORTING DOCUMENTS.
3. REVIEW YOUR APPLICATION TO ENSURE ALL INFORMATION IS ACCURATE.

COMMON MISTAKES TO AVOID

TO ENSURE A SMOOTH PROCESS, BE AWARE OF COMMON MISTAKES THAT APPLICANTS OFTEN MAKE:

- **INCOMPLETE INFORMATION:** FAILING TO PROVIDE ALL NECESSARY DETAILS CAN LEAD TO DELAYS.
- **OUTDATED DOCUMENTATION:** ENSURE ALL SUPPORTING DOCUMENTS ARE CURRENT AND RELEVANT.
- **INCORRECT SIGNATURES:** MAKE SURE THE FORM IS SIGNED BY THE APPROPRIATE PARTY.

YES, A SPONSOR CAN SUBMIT MULTIPLE FORM I-134A APPLICATIONS FOR DIFFERENT BENEFICIARIES, PROVIDED THEY CAN DEMONSTRATE SUFFICIENT FINANCIAL SUPPORT FOR EACH.
