- COMPLETED APPLICATION FORM
- ANY REQUIRED FEES

UNDERSTANDING THE LICENSING EXAM STRUCTURE

THE USFK DRIVER LICENSING EXAM CONSISTS OF TWO PRIMARY COMPONENTS: A WRITTEN TEST AND A PRACTICAL DRIVING TEST.

WRITTEN TEST

THE WRITTEN PORTION OF THE EXAM ASSESSES THE CANDIDATE'S KNOWLEDGE OF TRAFFIC LAWS, ROAD SIGNS, AND SAFE DRIVING PRACTICES. IT TYPICALLY COVERS THE FOLLOWING TOPICS:

- SOUTH KOREAN TRAFFIC LAWS
- DRIVING ETIQUETTE
- VEHICLE OPERATION AND SAFETY
- EMERGENCY PROCEDURES

CANDIDATES SHOULD STUDY THE USFK DRIVER'S HANDBOOK, WHICH PROVIDES ESSENTIAL INFORMATION FOR THE WRITTEN TEST.

PRACTICAL DRIVING TEST

THE PRACTICAL DRIVING TEST EVALUATES THE CANDIDATE'S DRIVING SKILLS IN A CONTROLLED ENVIRONMENT. THIS PORTION INCLUDES:

- A PRE-TRIP INSPECTION
- BASIC MANEUVERS SUCH AS PARALLEL PARKING AND THREE-POINT TURNS
- ADHERENCE TO TRAFFIC SIGNS AND SIGNALS
- DEMONSTRATION OF SAFE DRIVING PRACTICES

CANDIDATES MUST PROVIDE THEIR OWN VEHICLE FOR THE PRACTICAL TEST, AND IT MUST MEET THE SAFETY STANDARDS SET BY USFK REGULATIONS.

PREPARATION FOR THE EXAM

PREPARING FOR THE USFK DRIVER LICENSING EXAM REQUIRES A COMBINATION OF STUDY AND PRACTICE. HERE ARE SOME EFFECTIVE STRATEGIES:

1. **REVIEW THE USFK DRIVER'S HANDBOOK:** FAMILIARIZE YOURSELF WITH THE MATERIAL, AS IT COVERS EVERYTHING YOU NEED TO KNOW FOR BOTH THE WRITTEN AND PRACTICAL TESTS.

5. **STUDY LOCAL TRAFFIC SIGNS:** FAMILIARIZE YOURSELF WITH SOUTH KOREAN TRAFFIC SIGNS, AS THEY MAY DIFFER FROM THOSE IN THE UNITED STATES.

COMMON QUESTIONS AND ANSWERS

3. ARE THERE ANY FEES ASSOCIATED WITH THE LICENSING EXAM?

NO, SERVICE MEMBERS AND THEIR FAMILIES MUST POSSESS A VALID U.S. DRIVER'S LICENSE TO APPLY FOR A USFK DRIVER'S LICENSE. HOWEVER, SOME TEMPORARY EXCEPTIONS MAY APPLY FOR VISITORS.

5. WHAT SHOULD I DO IF I FAIL THE EXAM?

IF YOU FAIL THE WRITTEN OR PRACTICAL EXAM, YOU CAN RETAKE THE TEST AFTER A DESIGNATED WAITING PERIOD, TYPICALLY RANGING FROM ONE TO TWO WEEKS. USE THIS TIME TO REVIEW THE MATERIAL FURTHER AND PRACTICE YOUR DRIVING SKILLS.

TIPS FOR SUCCESS ON THE EXAM DAY

ON THE DAY OF THE EXAM, CANDIDATES SHOULD KEEP THE FOLLOWING TIPS IN MIND TO ENHANCE THEIR CHANCES OF SUCCESS:

- **ARRIVE EARLY:** GIVE YOURSELF PLENTY OF TIME TO CHECK IN AND REDUCE ANY PRE-EXAM ANXIETY.
- **BRING REQUIRED DOCUMENTS:** ENSURE YOU HAVE ALL NECESSARY DOCUMENTS, INCLUDING YOUR U.S. DRIVER'S LICENSE, MILITARY ID, AND COMPLETED APPLICATION FORM.
- **STAY CALM:** ANXIETY CAN AFFECT PERFORMANCE, SO TAKE DEEP BREATHS AND REMAIN FOCUSED.
- **FOLLOW INSTRUCTIONS:** LISTEN CAREFULLY TO THE EXAMINER'S INSTRUCTIONS DURING BOTH THE WRITTEN AND PRACTICAL TESTS.
- **DRIVE SAFELY:** DURING THE PRACTICAL TEST, DEMONSTRATE SAFE DRIVING HABITS AND ADHERE TO ALL TRAFFIC LAWS.

THE USFK DRIVER LICENSING EXAM IS A TEST ADMINISTERED BY THE UNITED STATES FORCES KOREA TO EVALUATE THE DRIVING KNOWLEDGE AND SKILLS OF INDIVIDUALS WISHING TO OPERATE VEHICLES ON MILITARY INSTALLATIONS IN SOUTH KOREA.

WHO IS REQUIRED TO TAKE THE USFK DRIVER LICENSING EXAM?

ALL PERSONNEL WISHING TO DRIVE ON US MILITARY INSTALLATIONS IN KOREA, INCLUDING MILITARY MEMBERS, CIVILIANS, AND CONTRACTORS, MUST PASS THE USFK DRIVER LICENSING EXAM.

WHAT TOPICS ARE COVERED IN THE USFK DRIVER LICENSING EXAM?
