- PASSING THE VIRGINIA CONTRACTOR EXAM.
- DEMONSTRATING FINANCIAL RESPONSIBILITY AND STABILITY.
- SUBMITTING A COMPLETED APPLICATION FORM.
- PROVIDING PROOF OF LIABILITY INSURANCE.
- UNDERGOING A CRIMINAL BACKGROUND CHECK.
