5. **FUNCTIONAL CAPACITY ASSESSMENT:** DETERMINATION OF PHYSICAL, COGNITIVE, AND PSYCHOLOGICAL ABILITIES RELEVANT TO WORK TASKS.

THESE COMPONENTS ARE INTEGRATED TO FORM A COMPREHENSIVE PICTURE OF THE VETERAN'S VOCATIONAL POTENTIAL AND LIMITATIONS, GUIDING THE FINAL DETERMINATION OF UNEMPLOYABILITY.

HOW VOCATIONAL ASSESSMENT INFLUENCES TDIU ELIGIBILITY

THE VOCATIONAL ASSESSMENT IS PIVOTAL IN INFLUENCING WHETHER A VETERAN QUALIFIES FOR TDIU BENEFITS.
