CLINICAL ROLES AND RESPONSIBILITIES

DNPs ARE TRAINED TO APPLY EVIDENCE-BASED PRACTICE TO IMPROVE PATIENT CARE AND HEALTH OUTCOMES. UNLIKE RESEARCH-FOCUSED DOCTORATES, DNPs UTILIZE CLINICAL EXPERTISE TO TRANSLATE RESEARCH FINDINGS INTO PRACTICAL HEALTHCARE SOLUTIONS.

ADVANCED PATIENT CARE

DNPs OFTEN SERVE AS CLINICAL EXPERTS IN VARIOUS SPECIALTIES, INCLUDING FAMILY PRACTICE, PEDIATRICS, PSYCHIATRIC MENTAL HEALTH, AND ACUTE CARE. THEY DIAGNOSE AND MANAGE COMPLEX HEALTH CONDITIONS, PRESCRIBE MEDICATIONS, AND DEVELOP INDIVIDUALIZED TREATMENT PLANS.
