OVERVIEW OF THE CMA EXAM AND ITS STRUCTURE

THE CERTIFIED MANAGEMENT ACCOUNTANT (CMA) EXAM IS A CHALLENGING PROFESSIONAL CERTIFICATION TEST ADMINISTERED BY THE INSTITUTE OF MANAGEMENT ACCOUNTANTS (IMA). RETAKE POLICIES AND RESTRICTIONS AFTER MULTIPLE FAILURES

THE IMA SETS SPECIFIC RETAKE POLICIES FOR CANDIDATES WHO FAIL THE CMA EXAM. UNDERSTANDING THESE RULES IS ESSENTIAL TO AVOID UNNECESSARY DELAYS AND TO PLAN EXAM ATTEMPTS STRATEGICALLY.

WAITING PERIOD BETWEEN ATTEMPTS

THE IMA DOES NOT LIMIT THE NUMBER OF TIMES A CANDIDATE CAN ATTEMPT EACH PART OF THE CMA EXAM. CANDIDATES CAN RETAKE THE EXAM AS MANY TIMES AS NEEDED WITHIN THEIR THREE-YEAR ELIGIBILITY PERIOD. HOWEVER, FAILING THREE TIMES MAY PROMPT CANDIDATES TO REASSESS THEIR PREPARATION STRATEGIES.

REGISTRATION AND ELIGIBILITY REQUIREMENTS

EACH RETAKE REQUIRES A NEW REGISTRATION AND PAYMENT OF THE APPLICABLE FEES. CANDIDATES MUST MAINTAIN THEIR MEMBERSHIP WITH THE IMA AND ENSURE THEIR ELIGIBILITY PERIOD IS ACTIVE TO CONTINUE ATTEMPTING THE EXAM.
