BY FOCUSING ON EMPOWERMENT, SOCIAL WORK PRACTITIONERS CONTRIBUTE TOWARD BUILDING SUSTAINABLE SOLUTIONS THAT ADDRESS BOTH IMMEDIATE AND STRUCTURAL ISSUES AFFECTING CLIENTS.

CONCEPTUAL FOUNDATIONS OF EMPOWERMENT
