UNDERSTANDING SCHOOL GOVERNANCE STRUCTURES

- **COMMUNITY AND PARENTS:** PLAY AN ADVISORY ROLE AND PARTICIPATE IN SCHOOL IMPROVEMENT INITIATIVES.

THESE LAYERS WORK INTERDEPENDENTLY TO MAINTAIN EDUCATIONAL QUALITY AND EQUITY, WITH EACH LEVEL ACCOUNTABLE FOR SPECIFIC GOVERNANCE FUNCTIONS.

STATE EDUCATION AGENCIES
