DIFFICULTY LEVEL AND PASS RATES

WHILE THIS SHIFT ALIGNS WITH PROFESSIONAL DEMANDS, IT MAY PRESENT CHALLENGES FOR CANDIDATES ACCUSTOMED TO TRADITIONAL STUDY METHODS.

ADAPTIVE TESTING CONSIDERATIONS

THOUGH THE CPA EXAM REMAINS A FIXED-FORM TEST, DISCUSSIONS ABOUT ADAPTIVE TESTING MODELS HAVE EMERGED WITHIN THE INDUSTRY.
