- **HISTORICAL CONTEXT:** COLONIAL HISTORIES AND PAST CONFLICTS SHAPE CURRENT REGIONAL IDENTITIES.

NORTH AMERICA: ECONOMIC POWERHOUSE AND POLITICAL INFLUENCE

NORTH AMERICA, COMPRISING PRIMARILY THE UNITED STATES, CANADA, AND MEXICO, IS A SIGNIFICANT WORLD REGION IN THE GLOBAL CONTEXT DUE TO ITS ECONOMIC SIZE, TECHNOLOGICAL INNOVATION, AND POLITICAL INFLUENCE. ECONOMIC INTEGRATION AND TRADE
