THE ROLE OF DISCIPLINARY CONTEXT

HUMANITIES AND SOCIAL SCIENCES WRITING

BUSINESS AND PROFESSIONAL WRITING

BUSINESS WRITING PRIORITIZES CLARITY, CONCISENESS, AND PRACTICAL RELEVANCE. REPORTS, PROPOSALS, AND EXECUTIVE SUMMARIES ARE COMMON GENRES. THE LANGUAGE IS DIRECT AND AUDIENCE-CENTERED, AIMING TO INFORM DECISION-MAKING AND FACILITATE ACTION. FORMATTING AND STYLISTIC CONVENTIONS ARE DESIGNED TO ENHANCE READABILITY AND PROFESSIONALISM.

EFFECTIVE WRITING STRATEGIES ACROSS DISCIPLINES

CHALLENGES IN WRITING WITHIN DISCIPLINES
